Anytime after the 1st 15 minutes of a scheduled shoot time constitutes a forfeiture of the deposit. It is the models responsibility to arrive on time at the studio or on location. Traffic, parking, distance, weather, and or wrong directions are not valid reasons for being late and will not prevent your deposit from being forfeited. You will receive no more than 6 edited web sized images with the EMG STUDIOS copyright logo. The photos will be of your choosing but will be approved by the photographer. These images will display the photographer's abilities and reflect the photographer's style and personal artistry.

You will have the opportunity to purchase full resolution images for printing and off-line portfolio use. Full resolution images will not bare the EMG STUDIOS logo. Web promotional images MUST include an EMG STUDIOS copyright logo. These images should be used for ALL internet promotional and portfolio purposes and should not be altered in any way; including but not limited to removing the logo, cropping, and hue or saturation changes without express written consent of the photographer unless another agreement has been reached and is in writing and signed by both model's and photographer.

Rights of reproduction of all the images, web sized or full resolution, are granted solely for the purpose of self-promotion, (for your portfolio) without the photographer's written consent. Any other reproduction or transfer included but not limited to; web banners, club flyers, and other graphics, will be granted only with the written consent of the photographer. In addition, the images provided to you should not be altered in any way, without the written consent of the photographer.

Any print requests of images taken during this test shoot should be referred back to the photographer and processed by him. If you decide to have these images printed elsewhere, the photographer is not responsible for color shifts or variations in tone due to different printing processes.

Any additional costs incurred by the model for this test shoot including by not limited to; travel, make-up artists, and or stylists, etc... are at the sole discretion of the model. The photographer is in no way responsible for these costs, for any purpose, foreseeable or unforeseeable, including but not limited to equipment malfunction, act of nature, sickness, or shoot cancellation by the photographer.

Chaperones are welcomed but, extras on the set are highly discouraged because; non models tend to interfere with the flow and energy of a photo shoot. Once the photographer feels that the chaperone has interfered with the shoot, the shoot ends. No refunds! If you think your chaperone may interfere with our shoot, it's best not to bring them. If you feel that you cannot trust the photographer and this is the reason you need a chaperone, maybe you shouldn't be working with him.
